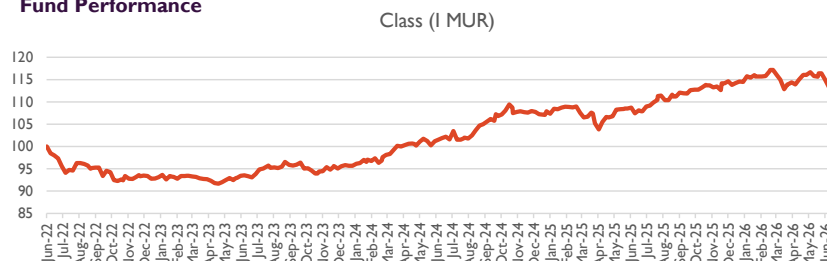

SEMDEX TR was up 1.85% in June. Gross Reserves stands at 9.83 Billion for the month of May. CPI YoY rose by 0.70 % for the month of May, compared to 3.60 % in the previous period. GVA YoY fell by 1.10 % on 1Q, compared to 3.10 % in the previous period.

International Market

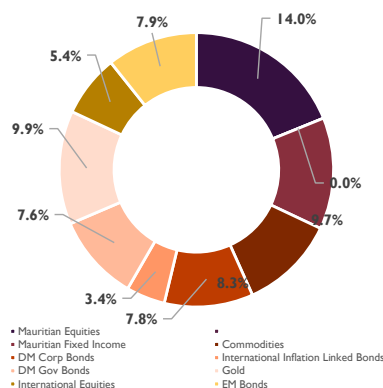
Global Bonds and Equities were down by -0.87% and down by -0.52% in MUR terms respectively while Global Commodities were down by -8.60% over the month.

Portfolio Comments

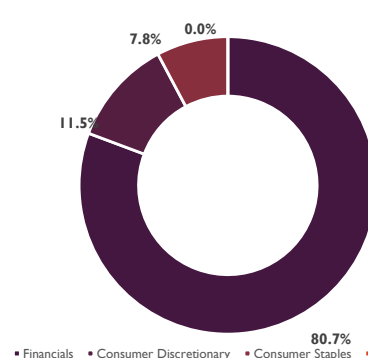
Our local portfolio contributed positively, while our international portfolio contributed negatively. A depreciation of the USD vs MUR contributed negatively to fund performance.
